Alamo Community Colleges. ACCD will hold an election for the purpose of electing a Trustee for District 2.

City of San Antonio. City of San Antonio will hold an election for the purpose of voting on 6 bond propositions.

Alamo Heights ISD. The Alamo Heights ISD will hold an election for the purpose of electing a Trustee for Place 2.

Comal ISD. The Comal ISD will hold an election for the purpose of electing a 2 Trustees, Place 6 and 7.

Harlandale ISD. The Harlandale ISD will hold an election for the purpose of voting on 3 bond propositions.

Medina Valley ISD. The Medina Valley ISD will hold an election for the purpose of electing a Trustees, for Single Member District 3 and 2 bond propositions.

North East ISD. The North East ISD will hold an election for the purpose of electing 3 Trustees, for Single Member District 2,3 and 7.

Northside ISD. The Northside ISD will hold an election for the purpose of voting on a bond proposition.

City of Castle Hills. The City of Castle Hills will hold an election for the purpose of electing a 2 Aldermen, Place 4 and 5 (Place 1 is unopposed) and voting on a sales and use tax..

City of Grey Forest. The City of Grey Forest will hold an election for the purpose of electing Mayor and Council, Place 2 (Place 4 is unopposed) and voting on a reauthorization of a sales and use tax.

The City of Helotes. The City of Helotes will hold an election for the purpose of electing a Councilmember, Place 2 (Place 1 and 4 are unopposed).

Town of Hollywood Park. The Town of Hollywood Park will hold an election for the purpose of electing Council Member, Place 2 (Mayor and Place 4 are unopposed) and voting on a reauthorization of a sales and use tax.

The City of Kirby. The City of Kirby will hold an election for the purpose of electing 3 Aldermen.

City of Leon Valley. The City of Leon Valley will hold an election for the purpose of electing Mayor and Council Member, Place 2 (Place 4 is unopposed).

City of Live Oak. The City of Live Oak will hold an election for the purpose of electing (Mayor Councilmembers Place 2 and 4 all unopposed) and a bond election and 8 charter amendments.

City of Olmos Park. The City of Olmos Park will hold an election for the purpose of electing Mayor and Council Member, Place 5 (Place 4 is unopposed) voting on a reauthorization of a sales and use tax.

The City of Shavano Park. The City of Shavano Park will hold an election for the purpose of electing 3 Aldermen (all unopposed) and a bond election.

The City of St. Hedwig. The City of St. Hedwig will hold an election for the purpose of electing Councilmember Place 2 (Mayor and Place 4 unopposed).

The City of Terrell Hills. The City of Terrell Hills will hold an election for a reauthorization of a sales and use tax.

City of Universal City. The City of Universal City will hold an election for the purpose of electing Mayor and 3 Council Members.

The City of Windcrest. The City of Windcrest will hold a bond election.
