



Early voting by personal appearance, will be conducted each weekday at those polling places designated by the Bexar County Elections Administrator.







A review of our records shows that the City of Castle Hills' 1/4% sales tax for Street Maintenance will expire on September 30, 2022, unless the city holds a reauthorization election as prescribed in Section 327.007, Tax Code. For sales tax elections we advise you to use statutory language when drafting ballot language. Please contact our office if you need assistance with this.

Please notify the Comptroller's office of the City's plans with respect to the continuation of this tax as soon as possible.
